



'Christmas Competition' – December 2018

Competition Terms and Conditions

1. Competition starts 12 noon Thursday 13th December 2018 and closes at 12 noon Monday 24th December 2018.
2. Information on how to enter and prizes form part of the Conditions of Entry. Entry into this competition deems acceptance of these Conditions of Entry.
3. Entry is open to all residents of Western Australia aged 18 years and above, except agents and contractors of Primewest Erskine Central Shopping Centre, who are not eligible to enter this competition.
